Work in Progress - From Rule-Followers to Rule-Makers: The Ontological Shift Behind the Zeroth Law

Article manuscript currently in development; jurisprudential analysis of Isaac Asimov's Robots and Empire. This piece explores the legislative genesis of the Zeroth Law, focusing on the transformation of robots from legal subjects to legal authors. Through an analysis of Giskard and Daneel's reasoning capacities, it asks whether their construction of the Zeroth Law marks a shift from artificial narrow to general intelligence, and what this might imply for the legal authority of non-human agents.

Work in Progress - Reassessing the Person-Thing Dichotomy: Electronic Personhood and the Threshold of AGI Article manuscript currently in development; interdisciplinary legal study on the conceptual limits of personhood. This paper interrogates the foundational binary of person and thing in private law in light of developments in AI. It explores whether AGI challenges the legal and conceptual boundaries that define subjecthood, focusing on the proposed category of "electronic personhood." Drawing from doctrinal, comparative, and cross-cultural perspectives, it questions whether the person-thing distinction remains analytically sufficient or whether an alternative, non-binary legal taxonomy is required. The work engages with Indigenous ontologies, epistemological critique, and literary analogies to rethink how legal systems categorise intelligence, agency, and relationality in a post-AGI future.
